13.1.3 - TELEPHONE CALLS TO PROSPECTS --- "THE RULES"

13.1.3.1 Time Period for Telephone Calls -- GENERAL RULE: Telephone calls to a prospect (parents or guardians) may not be made prior to June 15 immediately preceding the prospects senior year in high school; thereafter, staff members will not make such phone calls more than once per week. If more than one call per week occurs due to a scheduled official paid visit that is subsequently is canceled by the prospect, the violation will be considered an institutional violation per 2.8.1, however it will not affect the prospects eligibility.

13.1.3.1.1 The Football Exception: In division II FOOTBALL during a contact period, telephone contact may be made at the institutions discretion. **Calls must still be documented.**

13.1.3.2.1 During Conduct of Athletics Contest: Phone calls to a prospect (parents or guardians) cannot be made during the conduct of any of the institutions intercollegiate athletics contests in that sport until the competition has concluded and the coach has dismissed the team.

13.1.3.3.1 Official - Visit Exception: Institutional staff members may make unlimited phone calls to a prospect during the five days immediately preceding the prospects official visit to that institution.

13.1.3.3.2 Letter of Intent Signing Date Exception: Institutional staff members may make unlimited phone calls to a prospect on the initial date for the signing of the National Letter of Intent and during the two days immediately following the initial signing date.

WHO CAN CALL 13.1.3.4. Permissible Callers

13.1.3.4.1 Institutional Staff Members: In all sports, all coaches can call a prospect senior or junior college recruits. Phone calls are institutionally specific. So, if you are recruiting a multi-sport athlete, please discuss with the other sport who is calling that week.

13.1.3.4.1.1 Institutional Academic Advisors/Instructors: It is permissible for Academic Advisors or Faculty members to call a prospect. They must follow all the rules a coach would and it would count as the one phone call for all sports.

WHO CAN'T CALL 13.1.3.5. Non permissible Callers

13.1.3.4.2 Representative of Athletics Interests: IT IS NOT PERMISSABLE FOR AN ATHLETICS REPRESENTATIVE TO MAKE TELEPHONE CALLS TO A PROSPECT.

13.1.3.5.1 Enrolled Students and Student - Athletes: Enrolled student - athletes or enrolled students shall **not** make or participate in telephone calls to a prospects at the direction of a coaching staff member or financed by the institution or a representative of athletic interests; however they may receive telephone calls at the expense of the prospect subsequent to July 1 following the completion of the [prospect's junior year in high school].

FRIENDLY REMINDERS:

You can always receive phone calls from any recruits. Messages on the answering machine do not count as your one phone call.

Facsimiles and other electronically transmitted correspondence shall not be considered a phone call. NO TEXT MESSAGES 08/01/08 - Bylaw 13.02.11

You have unlimited phone calls the five days prior to an OFFICIAL VISIT and unlimited on the day of an OFF CAMPUS CONTACT.
